

TERMS AND CONDITIONS OF DENTAL INSURANCE POLICY PROMOTION ("the Promotion")

- The Promotion is jointly organised by MSIG Insurance (Singapore) Pte. Ltd. ("MSIG") and DBS Bank Ltd ("DBS") (collectively, the "Organisers"). Dental Insurance Policy is underwritten by MSIG and distributed by DBS.
- 2. The promotion period is from 1 October 2014 to 31 December 2014 (both dates inclusive) ("Promotion Period").
- 3. You will receive S\$10 worth of Takashimaya vouchers ("Gift") when you purchase Dental Insurance through our website during the Promotion Period. The Promotion is applicable to Dental Insurance Platinum or VIP Plan.
- 4. Each application is subject to MSIG's terms and conditions relating to eligibility and MSIG's acceptance of the application for Dental Insurance.
- Your entitlement to the Gift is only applicable for a first time purchase of Dental Insurance through our website or direct mailer during this Promotion Period. It does not apply to renewal policies with MSIG.
- 6. You agree that you accept the Gift subject to such terms and conditions that the Organisers may impose from time to time. The Gift will be sent by ordinary post by MSIG, together with the Dental Insurance Policy.
- 7. The Gift is non-redeemable, non- transferable, non-assignable and non-exchangeable for cash, credit or any other item in part or in whole. The Gift is non-replaceable and the Organisers are not obliged to replace any Gifts if they are lost, stolen or damaged.

- 9. MSIG is entitled to deduct an amount equivalent to the value of the Gift, which you accept and agree shall be S\$10, from the applicable premium to be refunded to you if you cancel your Dental Insurance within 60 days from the policy inception date of the Dental Insurance.

The Organisers are not liable for any injury, loss or damage whatsoever, whether direct or indirect, arising from or in connection with the Gift. The Organisers' decision on all matters relating to the Promotion will be at their absolute discretion and will be final and binding on the parties thereto.
