POSB Invest Equity Series 1 Tranche C is a four years eleven months Equity-Linked Structured Deposit whose return is linked to the performance of the shares of 3 Singapore companies.

The Structured Deposit will pay you a Fixed Payout Amount at an interest rate of 1.38% on 15 Apr 2011, 16 Apr 2012, 15 Apr 2013, 15 Apr 2014 and 1.86% on the Maturity Date. In addition, if Bonus Payout Event occurs, the Bank will pay the Bonus Payout Amount of 2.50% of the Principal Amount on the Maturity Date. Bonus Payout Event occurs when the return of each share in the Underlying Basket is equal to or greater than 20% in respect of the Fixing Date.
