

Terms and Conditions for DBS/POSB Credit Cards Activate and Get Cash Rebate Promotion (“Promotion”)

Participation in the Programme constitutes acceptance of these Terms and Conditions.

1. The **Promotion** is only applicable to selected DBS/POSB Principal Credit Cardmembers who are invited via Push Notification (“**PN**”) by DBS Bank Ltd (“**DBS**”) to participate (“**Cardmembers**”).
2. The S\$5 Cash Rebate (“**Cash Rebate**”) is limited to the first 2,000 **Cardmembers** who have successfully activated their DBS/POSB Credit Cards card via digibank Mobile, digibank Online or DBS website and make an eligible transaction (“**Eligible Transactions**”) within 14 days from the **PN** date (“**Promotion Period**”) (“**Eligible Cardmembers**”).
3. **Eligible Cardmembers** will receive a maximum S\$5 **Cash Rebate** regardless of the number of **Eligible Transactions** made.
4. **Eligible Transactions** refers to transactions that are in local and foreign currencies charged to DBS/POSB Credit Cards (“**Card**”) (i.e. transaction date) within 14 days of **PN** and posted in the **Card** account at the point of computation and fulfilment.
5. **Eligible Cardmembers** will receive the S\$5 **Cash Rebate** in their **Card** account within 3 months of **Promotion** end date.
6. The **Cash Rebate** shall be forfeited if the **Card** account is terminated or suspended within 3 months from the end of the **Promotion Period**.
7. The **Cash Rebate** is non-exchangeable, non-transferable and non-replaceable.
8. Cardmembers consent under the Personal Data Protection Act (Cap 26 of 8012) to the collection, use and disclosure of the Cardmembers’ personal data by/to DBS and such other third party as DBS may reasonably consider necessary for the purpose of the Promotion, and confirm that they agree to be bound by the terms of the DBS Privacy Policy, a copy of which can be found on www.dbs.com/privacy.
9. DBS may vary these terms and conditions of or suspend or terminate the Promotion at any time without any notice or liability to any party. DBS will not be obliged to enter into any correspondence on any matter concerning the Promotion.
10. These terms and conditions shall be read in conjunction with the DBS Cards General Promotions Terms and Conditions and DBS Card Agreement. In the event of any inconsistency, these terms and conditions shall prevail insofar as they apply to the Promotion. 11. These terms and conditions are governed by Singapore law, and Cardmembers irrevocably submit to the exclusive jurisdiction of the Singapore courts.

A person who is not a party these Terms and Conditions shall have no right under the Contracts (Rights of Third Parties) Act (Cap 53B) to enforce any of these Terms and Conditions and notwithstanding any terms herein, the consent of any third party is not required for any variation (including any release or compromise of any liability) or termination of these Terms and Conditions.
