

**DBS Live Fresh Card X St Jerome's – The Hotel Glamping Trip (“Campaign”)**

1. Applicable to DBS Live Fresh Cardmembers (“Cardmembers”) whose DBS Live Fresh card accounts are valid and in good standing with DBS.
2. Valid from 21 January 2017 to 31 March 2017 (“Campaign Period”).
3. To qualify, Cardmember must:
  - (A) Have registered via SMS to 76060 within the Campaign Period in the following format:  
livefresh<space>NRIC No.<space>last 4 digits of card number  
E.g.: livefresh S1234567A 8888; AND
  - (B) Be one of the three (3) Cardmembers with the most Qualifying Spend (as defined below) charged to his/her DBS Live Fresh card account during the Campaign Period.

Qualifying spend is based on posted local and foreign retail sales, posted recurring bill payment, posted 0% interest-free instalment plan, posted My Preferred Payment instalment plan, but it excludes interest, finance charges, cash withdrawal, balance transfer, smart cash, AXS payments, SAM online bill payments, bill payments via internet banking and all fees charged by DBS. Supplementary card spend can be included in the calculation of Qualifying Spend.
