### **NOTICE OF EARLY REDEMPTION**

You will receive the following Early Redemption Amount on 5 March 2012:

You will receive a letter informing you of this early redemption by the Bank. The Principal Amount of your investment and the payout will either be credited into your account on 5 March 2012, or paid by Cashier's Order (CO) if you have requested for payment by CO or if we are unable to credit your account. You will receive the CO within 10 business days from 5 March 2012.

As your investment will be early redeemed by the Bank, if you have been extended an AssetLine overdraft facility secured against this investment, we will cancel the AssetLine. Any amounts outstanding under your AssetLine will be set off against the proceeds from this early redemption on 5 March 2012.
