# **Expedite clearance of goods to avoid demurrage charges**



Clear your cargo before the receipt of transport document by DBS.



Applicable for shipping documents under Letter of Credit (LC) and Import Bills under Collection.

## • At a glance

- Shipping Guarantee/Airway Bill Endorsement is a letter of indemnity from the bank to the transport company to release goods to you (importer) without presentation of the original Bill of Lading (BL)/Airway Bill (AWB).
- You submit a copy of invoice and BL and shipping company's indemnity form for sea shipment or a copy of the AWB for air shipment for DBS' endorsement.
- After DBS' endorsement, the transport company will release the cargo to you based on the indemnity form endorsed by Bank.
- The indemnity will be cancelled only when the original BL or AWB is surrendered to the transport company for redemption.

- Companies buying perishable goods such as seafood, meat, fruits, vegetables, cut flowers and dairy products.
- Goods that require short distance shipment by sea or air.
- Wholesalers and importers such as supermarkets.
