

## TRADE AUTOFAX SERVICE REGISTRATION FORM

### Scope of Service

With **Trade Autofax Service**, you will receive immediate fax notification of your trade transaction status. For example:

- Be informed immediately when your import Letter of Credit (LC) documents arrive, giving you more time to clear your goods; and
- Be notified when your export LC is received to quickly gear up for production and shipment, prepare your export documentation etc.

### Types of Fax Notification Available

- Notification of receipt of import LC documents
- Notification of receipt of import Documents against Acceptance (DA) / Documents against Payment (DP) collection documents
- Notification of receipt of export LCs
- Customers' copy of DBS LCs issued on their behalf
- Due date advices for:
  - (a) Import bill under LC
  - (b) Import / Export collection under DA / DP
  - (c) Export LC negotiation
- Financing advice
- Debit / Credit transaction advice (printed notices will also be mailed)

- Please indicate only one (1) facsimile number clearly on this form.
- Signatory(ies) and company stamp (if required) should adhere to the current account mandate
- No acknowledgement of DBS' receipt of this form shall be given to you, nor will DBS expect an acknowledgement of receipt from you upon your receipt of the fax notifications.
- Should there be any change in the details given below (including facsimile number) or intention to terminate this service, kindly inform DBS in writing giving at least two (2) weeks' prior notice.
