

# **SME Digipay Promotion**

**Promotion Period:** 27 February 2024 – 31 May 2024 (both dates inclusive) **Qualifying Period:** 1 March 2024 – 31 May 2024 (both dates inclusive)

## **Qualifying Process:**

- 1. Register your interest through the registration page from 27 February 2024 to 31 May 2024.
- 2. Make recurring payments to the selected qualifying merchants with your DBS Commercial Card
- 3. Clock a minimum spend of \$\$300 per qualifying merchant during the Qualifying Period.
- 4. Each qualified transaction with each qualifying merchant will be rewarded with \$\$30 cash rebates. Total cash rebates will be capped at \$\$300 per company.

- Payments made via telephone or mail order;
- Payments to educational institutions;

- Payments to government institutions and services (court cases, fines, bail and bonds, tax
  payment, postal services, parking lots and garages, intra-government purchases and any other
  government services not classified here);

- any other transactions determined by DBS from time to time.



#### Terms and Conditions Governing SME Digipay Promotion ("Promotion")

Participation in the Promotion constitutes acceptance of these Terms and Conditions.

- This Promotion is limited to DBS Commercial Card holders with an Eligible Card only.
- "Eligible Card" means Cardmember's card account(s) must not be suspended and in good standing (i.e. to abide by the Terms and Conditions listed in the DBS Card Agreement) with DBS throughout the Promotion Period and Fulfillment Period. Cardmembers whose card account(s) fulfils the Qualifying Spend during the Qualifying Period but, for any reason, is terminated/cancelled/replaced before or during the Fulfillment Period will not be able to receive the Reward(s).
- "Qualifying Spend" refers to purchases in local and foreign currencies that have been charged to a DBS
  Commercial Card with a minimum amount of \$\$300 for each qualifying merchant listed during the
  Qualifying Period. Only purchases posted to the Eligible Card Account after registration will be
  considered as Qualifying Spend. DBS shall not be responsible for any failure or delay in posting of sales
  transactions which may result in Cardmembers being ineligible for the promotion.
- Each Qualifying Spend will be rewarded with S\$30 cash rebates. Total cash rebates will be capped at S\$300 per company.
- This Promotion is valid for cardholders who are new or does not have any recurring bill payment to the
  Qualifying Merchants in the last 3 months prior to the Qualifying Period. Existing corporate cards with
  recurring arrangement will not qualify for this Promotion.

  for the Promotion. These values are subject to change based on the prevailing exchange rate on the posting
  date.
