



Terms and Conditions Governing DBS x GoCorp Promotion ("Promotion")

Participation in the Promotion constitutes acceptance of these Terms and Conditions.

Definitions:

- "Eligible Card" means Cardmember's card account(s) must not be suspended and in good standing (i.e. to abide by the Terms and Conditions listed in the DBS Card Agreement) with DBS throughout the Promotion and Redemption Period. Cardmembers whose card account(s) fulfil the Qualifying Spend during the Promotional Period but, for any reason, is terminated/cancelled/replaced before or during the Redemption Period will not be able to receive the Reward(s).
- "Qualifying Spend" refers to GoCorp rides that have been charged to a DBS Commercial Card.
- "Qualifying Criteria" refers to requirements to meet to qualify for this promotion.

Registration Period:

• 15 April – 30 September 2023 (both dates inclusive).

Qualifying Period:

- DBS Signup Bonus:
 15 April 30 September 2023 (both dates inclusive).
- GoCorp Signup Ride Vouchers:
 15 April 30 November 2023 (both dates inclusive).

Qualifying Criteria:

- 1. This promotion is limited to the <u>first 200 companies</u> that are currently <u>not an existing user</u> of GoCorp and have registered through the GoCorp signup <u>page</u>, quoting "**DBSGC**" under "Referral Code (if any)" field.
- 2. Upon successful onboarding, companies will be eligible for the promotion, provided Qualifying Criteria has been met and the promotion is not expired or fully redeemed.

DBS Signup Bonus

- 1. Minimum spend criteria of <u>\$\$5,000</u> during Qualifying Period.
- 2. Upon meeting the minimum spend criteria, each registered company will receive a \$\$100 sign-up horus
- Only transactions posted to the Eligible Card Account <u>after registration</u> will be considered as Qualifying Spend. DBS shall not be responsible for any failure or delay in posting of sales transactions which may result in Cardmembers being ineligible for the promotion.

GoCorp Signup Ride Vouchers

- 1. Minimum spend criteria of <u>S\$100 per month</u> during Qualifying Period. Valid for the first 3 months of onboarding.
- 2. Upon meeting the minimum spend criteria, each registered company will receive 10% of their monthly spend value in the form of ride vouchers (in denominations of \$\$10). Total voucher amount will be capped at \$50 per month for the first 3 months of onboarding.





DBS Signup Bonus

- 1. Fulfillment period for DBS x GoCorp Partnership Campaign will be 60 calendar days after the qualifying period. Cash rebate will be credited to your Qualifying Card with the highest spend and reflected in your next monthly account statement.
- 2. DBS' decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.

GoCorp Signup Ride Vouchers

- 1. Up to \$\$50 ride vouchers (5 ride vouchers of \$\$10 EACH) per calendar month, valid for the first 3 months of onboarding. Capped at \$\$150 ride vouchers per company.
- 2. Ride vouchers in the form of voucher codes will be awarded in the subsequent month. Voucher codes will have a validity period of 60 days upon issuance.
