

## Terms and Conditions for DBS/POSB Credit Card Acquisition x Fave Promotion ("Terms and Conditions")

- 1. The DBS/POSB Credit Card Acquisition x Fave Promotion ("Promotion") is valid from **1 September to 30 April 2021** ("Promotion Period"), both dates inclusive.
- 2. To qualify for the Promotion, customer ("Eligible Cardmember") must fulfil the following:
  - a. is a New Cardmember who apply online for a principal DBS/POSB Credit Card ("Eligible Card");
  - b. has the Eligible Card approved by DBS during the promotion period;
  - c. has entered 'DBSFAVE' in the promo code field during the online application; and
  - d. must have a DBS PayLah! App in order to retrieve the coupons from this promotion. To apply for a DBS PayLah! account, cardmember will need a unique Singapore registered 8-digit mobile number.
- 3. "New Cardmember" is defined as customers who are currently not holding any Principal DBS/POSB Credit Card and have not cancelled any DBS/POSB Credit Card(s) within the last 12 months.
- 4. "Gift" refers to \$\$200 worth of Fave gift codes in \$\$50 denomination each for single use only and are not stackable. A minimum spend of \$\$80 is required to utilize the \$\$50 gift code.

- 7. "Eligible Card" refers to either a DBS Live Fresh Card, DBS Altitude Visa Card, DBS Altitude Amex Card, DBS Woman's Platinum Card, DBS Woman's World Card or POSB Everyday Card only.
