

Terms and Conditions for DBS/POSB Credit Card x Lazada Promotion (“Terms and Conditions”)

1. The DBS/POSB Credit Card x Lazada Promotion (“Promotion”) is valid from **1 December 2020 to 31 May 2021** (“Promotion Period”), both dates inclusive.
2. To qualify for the Promotion, customer (“Eligible Cardmember”) must fulfil the following:
 - a. is a New Cardmember who apply online for a principal DBS/POSB Credit Card (“Eligible Card”);
 - b. has the Eligible Card approved by DBS during the promotion period;
 - c. has entered ‘**DBSLAZ**’ in the promo code field during the online application; and
 - d. has a DBS PayLah! account to retrieve the vouchers from this promotion. To apply for a DBS PayLah! account, you will first need to download the app from the respective app stores then sign up via MyInfo or via your digibank account. Click [here](#) to find out more.
3. “New Cardmember” is defined as customers who are currently not holding any Principal DBS/POSB Credit Card and/or have not cancelled any DBS/POSB Credit Card(s) within the last 12 months.
4. “Gift” refers to the Lazada vouchers that will be issued in S\$50 denominations each, for single use only and are not stackable with other brands', sellers' and Lazada campaign collectible vouchers. A minimum spend of S\$80 is required to utilize the S\$50 voucher. The Gift will be awarded to the Eligible Customer via voucher codes issued on DBS PayLah! 6. "Eligible Card" refers to either a DBS Live Fresh Card, DBS Altitude Visa Card, DBS Altitude Amex Card, DBS Woman’s Platinum Card, DBS Woman’s World Card or POSB Everyday Card only.
7. The Gift is non-exchangeable and not redeemable for cash.
8. The use of the Gift may be subject to additional terms and conditions imposed by our campaign partner. Validity of voucher will be specified upon collection of vouchers from the Lazada page.
