

## Terms and Conditions Governing the DBS Live Fresh Student Card Application Promotion (“Promotion”)

1. The Promotion is from 1 July to 31 December 2019 (“**Promotion Period**”).
2. To qualify for this Promotion, customers (“**Qualified Cardmembers**”) must:
  - a. apply for a principal DBS Live Fresh Student Card (“**Card**”) and the Card must be approved during the Promotion Period;
  - b. not have cancelled their Card within the last 12 months prior to the commencement date of the Promotion Period; and
  - c. charge a minimum of S\$150 (“**Qualifying Spend**”) to the DBS Live Fresh Student Card Account (“**Card Account**”) within 30 days from Card Approval Date (based on transaction posting date) to receive a S\$10 foodpanda voucher (“**Gift**”).

For avoidance of doubt, transaction posting date means the date on which the transaction is posted to your account after the Bank has received the transaction information from the merchant.

3. Qualifying Spend is based on transacted and posted retail sales and recurring bill payment, and excludes:
  - i. payments made via AXS, SAM and eNETS;
  - ii. payments to educational institutions;
  - iii. payments to financial institutions (including banks, online trading platforms and brokerages);
  - iv. payments to government institutions and services (court cases, fines, bail and bonds, tax payment, postal services, parking lots and garages, intra-government purchases and any other government services not classified here);
  - v. payments to insurance companies (sales, underwriting and premiums);
  - vi. payments to non-profit organisations;
  - vii. payment or top-up of funds to payment service providers, prepaid accounts and any pre-paid accounts (e.g. EZ-Link, NETS FlashPay, Singtel Dash);
  - viii. transactions related to betting (including casino levy payment, lottery tickets, casino gaming chips, off-track betting, and wagers at race tracks);
  - ix. transactions related to crypto currencies;
  - x. payments made to CardUp, iPaymy, Mileslife and SmoovPay;
  - xi. payments to hospitals;
  - xii. payments to professional service providers (including but not limited to accounting, auditing, bookkeeping services, advertising services, funeral services, legal services and attorneys);
  - xiii. payments made via online banking;
  - xiv. payments made via telephone or mail order;
  - xv. payments to utility bill companies;
  - xvi. instalment payment plan purchases, preferred payment plans, balance transfer, fund transfer, cash advances, annual fees, interest, late payment charges, all fees charged by

- DBS, miscellaneous charges imposed by DBS (unless otherwise stated in writing by DBS);  
and
- xvii. any other transactions determined by DBS from time to time.
4. The Gift will be mailed to Qualified Cardmembers by ordinary post no later than 60 days from their Card Approval Date at their mailing addresses in DBS' records. It is the responsibility of customers to ensure that their mailing addresses in DBS' records are up to date.
  5. Any balance payment must be made with a DBS Live Fresh Student Card.
  6. The Gift will expire within 3 months from the date of issuance of the promo code.
  7. The Gift is strictly non-transferable, non-assignable and non-exchangeable.
  8. DBS reserves the right to substitute or replace the Gift with another gift of similar value without giving any prior notice or liability to any party.
  9. DBS' decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.
  10. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any notice or liability to any party.
  11.
