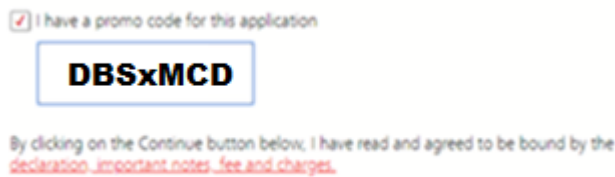


Terms and Conditions for DBS/POSB Cards McDelivery Sign Up Promotion (“Promotion”)

1. This promotion is valid from 8 August 2019 – 30 September 2019 (“Promotion Period”).
2. To qualify for this Promotion, customer (“Eligible Cardmember”) must fulfil the following during the Promotion Period:
 - a. be a New Cardmember;
 - b. have applied online for a principal DBS/POSB Credit Card (“Eligible Card”)
 - c. have entered ‘DBSxMCD’ in the promo code field during the online application;



Promo Code is not case-sensitive.

- d. have a Eligible Card approved
 - e. have charged McDelivery order(s) via McDelivery website or McDelivery App to the Eligible Card within 120 days from Card Approval Date
3. “New Cardmember” is defined as Customers who are currently not holding any Principal DBS/POSB Credit Card and/or have not cancelled any DBS/POSB Credit Card(s) within the last 12 months.
4. "Eligible Card" refers to either a DBS Live Fresh Card, DBS Altitude Visa, DBS Altitude Amex Card, DBS Black Visa, DBS Black Amex Card, DBS Woman’s Platinum, DBS Woman’s World Card or POSB Everyday Card only.
5. “Gift” refers to S\$10 cashback per McDelivery order up to a maximum of 12 orders.
6. The Gift will be credited to the Card Account to the Eligible Customer within 120 days from the date that McDelivery transaction is charged to the Eligible Card.
7. Limited to (1) Gift per New Cardmember regardless of the number of Eligible Cards applied or approved during the same period.
8. DBS’ decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.
9. DBS will not account for any failure of delay in posting of sales transactions which may result in any customer being omitted from enjoying the benefits of this Promotion.
