Terms and Conditions Governing Overseas Cash Withdrawal Promotion (“Promotion”)

Participation in the Promotion constitutes acceptance of these Terms and Conditions.

1. Promotion shall run from 7 August to 31 December 2019 (“**Promotion Period**”).
2. Promotion is open to cardmembers who hold a DBS/POSB Credit Card, Debit Card or ATM Card that is linked to a savings/current account (“**Eligible Card**”).
3. As part of this Promotion, cardmembers get to receive a S\$10 Takashimaya Gift Voucher (“**Gift Voucher**”) when they meet all the following requirements during Promotion Period.
 - (i) Be among the first 10,000 cardmembers to successfully register for the Promotion (“**Eligible Cardmembers**”); and
 - (ii) Make a minimum of 2 overseas cash withdrawals in a calendar month (“**Qualifying Withdrawals**”).
4. Qualifying Withdrawal refers to cash withdrawals made from overseas ATMs and withdrawn from the linked savings/current account of the Eligible Card. It excludes cash advance withdrawals through credit limit.
5. Each Eligible Cardmember can receive up to S\$20 worth of Gift Vouchers during Promotion Period. Gift Voucher(s) will be mailed to Eligible Cardmembers at their mailing address as per bank records by 31 March 2020.
6. Each Eligible Cardmember may only register once for this Promotion regardless of the number of Eligible Cards he/she holds. If a Cardmember registers multiple times during the Registration Period, only the first valid registration shall be considered for the purposes of this Promotion and all preceding registrations (together with any Qualifying Withdrawals made in the interim) shall be considered null and void. Please ensure accuracy of information provided on the online registration form as inaccurate information may result in Eligible Cardmembers from being omitted for the Promotion.
7. Cardmember’s Eligible Card and/or primary Current or Savings Account must be at good standing and conducted in a proper and satisfactory manner as determined by DBS in its sole discretion at the time of mailing the Gift Voucher(s). In the event that the relevant account is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reason whatsoever before the Gift Voucher(s) is/are mailed, DBS reserves the right not to mail the Gift Voucher(s). DBS Credit Card Agreement, DBS Debit Card Agreement, DBS Cards Promotion Terms and Conditions and Terms and Conditions Governing Accounts apply, a copy of which can be found on www.dbs.com.sg.
8. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any notice or liability to any party.
