

## **Terms and Conditions Governing the AXS Promotion Up to S\$20 Cashback with DBS Points redemption (“Promotion”)**

Participation in the Promotion constitutes acceptance of Terms and Conditions governing it.

1. The Promotion is valid from 1 April 2024 till 30 June 2024 (“Promotion Period”).
2. The Promotion is available on AXS m-Station app (“App”) only. Only DBS/POSB VISA or MasterCard Credit or Debit Cardmembers (“Customers”) are eligible to participate in this Promotion during the Promotion Period.
3. To be eligible for the Promotion, a customer must:
  - a. Redeem at least S\$100 worth of DBS Points for payment on AXS m-Station app (excluding the use of any promotional or voucher codes) within a single transaction (“Eligible Customer”) to receive the S\$10 cashback (“Cashback”), or
  - b. Redeem at least S\$180 worth of DBS Points for payment on AXS m-Station app (excluding the use of any promotional or voucher codes) within a single transaction (“Eligible Customer”) to receive the S\$20 cashback (“Cashback”).
4. Promotion is only limited to the first 1,000 monthly redemptions within the promotion period.
5. All cashback promotions are mutually exclusive. Each eligible customer is only entitled for either S\$10 or S\$20 cashback for each single transaction.
6. Redemption with POSB Daily\$ will not be eligible for the cashback.
7. Eligible Customer will have the Cashback credited into their Card Account within 2 weeks after promotion period ends. Each calendar month is considered as an individual campaign month.
8. In the event that the Eligible Customer’s card account is terminated or suspended for any reason during the Promotion Period, the said Customer will be disqualified from the Promotion and any Cashback earned shall be automatically forfeited or cancelled.
9. Successful redemptions with DBS Points are non-refundable and non-reversible.
10. DBS reserves the right to claw back the Cashback from customers who have their redemptions reversed or refunded in the event of any unforeseen circumstances.
