

## Terms and Conditions Governing the DBS Points to Shopee Coins Promotion Bonus 888 Shopee Coins with DBS Points redemption (“Promotion”)

Participation in the Promotion constitutes acceptance of Terms and Conditions governing it.

1. The Promotion is valid from 6 January 2024 till 12 February 2024 (“Promotion Period”).
2. The Promotion is available on Shopee App (“App”) only. All DBS Cardmembers are eligible to participate in this Promotion during the Promotion Period.
3. To be eligible for promotion, a customer must:
  - a. Redeem at least 2,000 DBS Points on the Shopee App (“Eligible Customer”) to receive the bonus amount of 888 Shopee Coins (“Bonus Coins”) in addition to the baseline amount of 1 Shopee Coin per 1 DBS Point (“Baseline Coins”) in a single transaction.
4. Each eligible customer is only entitled for a maximum of 888 Bonus Coins during the Promotion Period.

For illustration: If a customer redeems 2,000 DBS Points, a total of 888 Bonus Coins will be awarded.

DBS Points redeemed	Equivalent Shopee Coins
100	100 Baseline Coins + 0 Bonus Coins
2,000	2,000 Baseline Coins + 888 Bonus Coins
3,000	3,000 Baseline Coins + 888 Bonus Coins

5. Limited to first 5,000 redemptions within the Promotion Period.
6. Redemption with POSB Daily\$ will not be eligible for the bonus coins.
7. Bonus Shopee Coins will be credited by Shopee to customer’s Shopee account within 7 working days after redemption.
8. Successful redemptions with DBS Points are non-refundable and non-reversible.
