

## Terms and Conditions Governing the DBS/POSB Mastercard Travel Rewards (“Promotion”)

Participation in the Promotion constitutes acceptance of these Terms and Conditions (“Terms”).

1. Promotion is valid from 1 April to 30 September 2023 (“Promotion Period”).

2. “Eligible Card(s)” include:

3. “Customers” refer to customers with an Eligible Card.

4. Terms and conditions and validity period of each offer are specified on the respective offer pages and should be read in conjunction with this Terms.

5. “Eligible Purchases” include transactions made using an Eligible Card at participating overseas merchants online or instore following the terms and conditions of each offer.

6. Customers are automatically enrolled; no registration is required to enjoy cashback on Eligible Purchases.

7. Eligible Purchases must be made in foreign currency to be eligible for cashback in accordance with the terms of each offer. Transactions made in Dynamic Currency Conversion (DCC) are not eligible to enjoy cashback.

8. Cashback will be credited within 30 days to your Eligible Card the purchase was made on.

## **General Terms and Conditions**

9. Full payment must be charged in a single receipt to an Eligible Card unless otherwise stated.
10. Cashback awarded is non-exchangeable, non-transferrable and non-replaceable.
11. Cashback awarded for transactions that is subsequently reversed will be deducted from the Card Account accordingly.
12. Cashback will not be awarded to a Card Account which is delinquent, voluntarily or involuntarily closed or terminated or suspended for any reasons whatsoever during the Promotion Period and/or cashback crediting period.
13. Merchants' terms and conditions apply. Please see the respective merchant offer pages for details and terms of participation.
14. Cashback are non-redeemable for cash, non-transferable, non-assignable and non-exchangeable.
15. DBS shall not be responsible for any failure or delay in posting of retail transactions which may result in Cardmembers being ineligible for the Promotion.
16. DBS may vary the terms & conditions or discontinue any promotion/privileges at any time without any notice or liability to any party.
17. DBS' decision on all matters relating to its discounts, offers, prizes, gifts, complimentary items, vouchers, rebates, redemptions and privileges shall be final and binding.
