



## **Terms & Conditions of 'NETS, Now in Malaysia' AirAsia Big Points Lucky Draw (16 November 2019 – 31 December 2020) ("NETS, now in Malaysia")**

The 'NETS, now in Malaysia' campaign is carried out by Network for Electronic Transfers (Singapore) Pte Ltd ("NETS") and is subject to these terms and conditions ("Terms").

1. The 'NETS, now in Malaysia' campaign is open to all existing DBS/POSB, UOB and OCBC NETS enabled cardholders ("Customers").
2. The 'NETS, now in Malaysia' campaign shall be held from 16 November 2019 to 31 December 2020.
3. ("Participating Merchant") refers to any physical store in Malaysia that accepts NETS payment. Full list of Participating Merchants can be found at [www.nets.com.sg/overseas](http://www.nets.com.sg/overseas).
4. ("Qualified NETS Enabled Card") refers to DBS-NETS/ UOB-NETS/ OCBC-NETS debit cards issued by DBS, UOB or OCBC ("Participating Banks") in Singapore.
5. NETS may from time to time in its absolute discretion decide on the eligibility for participation in the Lucky Draw.

10. The lucky draw will be conducted on NETS premises on 15 January 2021.

12. Names of the lucky draw winners will also be publicly published on NETS website ([www.nets.com.sg](http://www.nets.com.sg)) by 15 February 2021.
13. By participating in this lucky draw, winners are also giving consent to the Participating Banks in releasing their names and contact information (e.g. mobile number, email address and address) to NETS for the purpose of announcing the winners on NETS website, redemption of the Prize and submitting an audited statement of account for the lucky draw the Singapore Police Force under the Common Gaming (Exemption) Notification 1997 / Remote Gambling (Exempt Persons) Order 2015.
14. To redeem the Prize, Customers will need to have a registered AirAsia Big Member account and provide their AirAsia Big Member ID (10 or 16 digits) and email address (registered with AirAsia) to NETS. Details will be stated in the redemption letter.
