

## **DBS PayLah! May to July 2023 QR Treasure Hunt**

### **Terms & Conditions**

#### **1. The Contest**

- 1.1. In these terms and conditions, "DBS PayLah!" refers to a mobile service offered by DBS that may be used by a user of the mobile service (individually a "**User**" and collectively, "**Users**") to transfer funds via the DBS PayLah! application for mobile devices that can be downloaded by Users from the Apple App Store and Google Play Store ("**Application**").
- 1.2. The DBS PayLah! May to July 2023 QR Treasure Hunt ("**Contest**") is hosted in DBS PayLah! and shall run from 12:00AM on 15 May 2023 to 11:59PM on 31 July 2023 ("**Contest Period**").
- 1.3. During the Contest Period, Eligible Users (as defined in Clause 2.1 below) stand a chance to win cash amounts (individually a "**Prize**", and collectively "**Prizes**") by scanning QR codes on DBS PayLah! arrow foamboard that are allocated at participating merchants island-wide which accept QR payments.

#### **2. Eligibility**

- 2.1. The Contest is open to eligible users who:
    - a) Have successfully downloaded the Application before or during the Contest Period; and
    - b) have successfully registered for a wallet account in the Application ("**Wallet Account**") before or during the Contest Period

(individually an "**Eligible User**" and collectively, "**Eligible Users**").
  - 2.2. To participate in the Contest, Eligible Users must have:
    - a) made a successful scan to pay transaction via DBS PayLah! at any participating merchant
    - b) successfully scanned the QR Code on the DBS PayLah! arrow foamboard that are allocated at participating merchants during the Contest Period.
  - 2.3. Limited to 1 scan per Eligible Transaction.
- #### **3. Prize**
- 3.1. The Prizes shall be allocated randomly and the quantum of each Prize is random.
  - 3.2. Each Eligible User will be entitled to receive up to 5 Prizes during the Contest Period.

- 3.3. Eligible Users who win a Prize (individually a “**Winner**”, and collectively “**Winners**”) will have the Prize credited to either the Winner’s Wallet Account or the bank account which is linked to their Wallet Account (“**Bank Account**”) on the day that the successful scan was made, or on any other date which DBS may at its sole discretion determined, provided that the Wallet Account is not closed or blocked when the Prize is being credited.

#### 4. General

- 4.1. Participation in the Contest constitutes acceptance of these terms and conditions.
- 4.2. Participants consent under the Personal Data Protection Act (Cap 26 of 2021) to the collection, use and disclosure of the participants’ personal data by/to the organizers, promoters or conductors of the Contest and such other third party for the purpose of administering the Contest and the participants confirm that they have read and agree to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on [www.dbs.com/privacy](http://www.dbs.com/privacy). By participating in the Contest, participants also agree and accept that the last 4 digits of their mobile number registered with the Wallet Account will be announced and published by DBS if they are a Winner of the Contest.
- 4.3. The decision of DBS on all matters relating to or in connection with the Contest shall be final and binding on the participants of the Contest. No correspondence or claims will be entertained.
- 4.4. DBS shall not be liable in any way to any participant of the Contest or any other person for any injury, loss, damage or expense arising out of or in connection with the Contest and the Prizes.
- 4.5. DBS may, at any time at its sole discretion and without prior notice, vary, modify, delete or add to these terms and conditions or suspend, postpone or terminate the Contest or shorten or extend the duration of the Contest without prior notice or any liability to any person.
- 4.6. DBS reserves the right to modify and/or terminate the Prize(s) at any time at its sole discretion and without any prior notice to the participants.
- 4.7. In the event of any inconsistency between these terms and conditions and any brochures, FAQs, marketing or promotional material relating to the Contest, these terms and conditions shall prevail.
