

DBS PayLah! x Lazada's SGAG Weekly Bazaar 20 April to 12 July 2021 Promotion ("Promotion")

Terms & Conditions

1. The Promotion

1.1. These Terms and Conditions govern the Promotion. Participation in the Promotion constitutes acceptance of these Terms and Conditions.

2. General Terms

2.1. "DBS PayLah!" is a mobile service offered by DBS Bank Ltd. ("DBS") that comprises a stored value facility that may be used by a user (individually a "User" and collectively, "Users") as a mobile wallet on their mobile device.

2.2. "DBS PayLah! Application" or "Application" refers to the DBS PayLah! Application for mobile devices that can be downloaded by the User from the Apple App Store and Google Play store.

2.3. As part of the DBS PayLah! Application, Users will have to register a wallet account (individually a "Wallet Account" and collectively, "Wallet Accounts").

3. Promotion Mechanic

3.1. The Promotion will commence on 20 April 2021 to 12 July 2021 for selected weeks, or when all first 1,000 successful transactions per Weekly Bazaar campaign period during this promotion period have been made as explained in Clause 3.5, whichever is earlier ("Promotion Period"). The respective Weekly Bazaar campaign period dates are listed in the table below.

- 3.2. To qualify for the Promotion, a User will need to make a successful DBS PayLah! Express Checkout with a minimum spend of S\$60.00 from the respective Weekly Bazaar’s start date, 0000hrs to the respective Weekly Bazaar’s end date, 2359hrs through Lazada mobile app (“**Qualifying Transaction**”) during the Promotion Period. The respective Weekly Bazaar campaign period dates are listed in the table above.
- 3.3. To qualify for the Promotion, a User will need to make a successful DBS PayLah! Express Checkout with a minimum spend of S\$60.00 from the respective Weekly Bazaar’s start date, 0000hrs to the respective Weekly Bazaar’s end date, 2359hrs through Lazada mobile app (“**Qualifying Transaction**”) during the Promotion Period.
- 3.4. Each S\$4 off voucher with a minimum spend of S\$60.00 to be used from the respective Weekly Bazaar’s start date, 0000hrs to the respective Weekly Bazaar’s end date, 2359hrs (“**Voucher Offer**”), limited to maximum of 1 Qualifying Transaction throughout the Promotion Period.
- 3.5. The Voucher Offer is collectible from the respective Weekly Bazaar’s start date, from 0000hrs to the respective Weekly Bazaar’s end date, 2359hrs via Lazada mobile app.
- 3.6. The Voucher Offer is refreshed daily at 9am, 12pm and 6pm from the respective Weekly Bazaar’s start date, 0000hrs to the respective Weekly Bazaar’s end date, 2359hrs.
- 3.7. The Voucher Offer is valid for the first 1,000 Successful PayLah! Qualifying Transactions per Weekly Bazaar campaign period during the promotion period.
- 3.8. The Voucher Offer is applicable for DBS PayLah! users only, excluding RedMart orders.

- 3.9. Collected vouchers will be automatically applied at checkout payment page upon selecting DBS PayLah! Express checkout as a payment method.
- 3.10. The Voucher is strictly non-transferable and non-assignable.
- 3.11. Voucher is applicable for single use only, and may be stacked with other free shipping, sellers' and Lazada campaign collectible vouchers.

4. General

- 4.1. Notwithstanding anything herein, DBS has the absolute discretion to determine the eligibility of a participant to participate in the Promotion or receive any Discount. The decision of DBS on all matters relating to or in connection with this Promotion shall be final. DBS shall not be obliged to enter into any correspondence on any matter concerning the Promotion.
- 4.2. By participating in this Promotion, participants agree to release and hold DBS harmless from any and all liability whatsoever for any injuries, losses or damages of any kind to any person or property arising from or in connection with, either directly or indirectly:
 - a) the awarding, acceptance, receipt, possession, use or misuse of any Cash Credit or parts thereof awarded pursuant to the Promotion; and
 - b) the participation in the Promotion or any Cash Credit-related activities.
- 4.3. DBS may vary these Terms and Conditions without notice, or withdraw or terminate the Promotion at any time without any notice or liability to any party. In the event of any inconsistency between these Terms and Conditions and any brochures, marketing or promotional materials relating to the Promotion, these Terms and Conditions shall prevail.
- 4.4. Participants consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of their personal data by/to the DBS' agent or vendors and such other third party for the purpose of the Promotion, and confirm that they have read and agree to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on www.dbs.com/privacy.
