



Terms and Conditions (“Terms and Conditions”) for Balance Transfer “Receive 1% Cashback and \$100 Dairy Farm Voucher (“Voucher”) Promotion” (“Promotion”)

1. Promotion is available from 3 May 2021 to 31 August 2021 (“Promotion Period”).
2. Successful applicants (“Applicants”) will be entitled to **1% Cashback** (“Cashback”) on approved loan amount, **capped at S\$500** if the following conditions are satisfied within the Promotion Period:
 - (a) Approved loan amount must be at least **S\$10,000 and above** in a single application or combined applications on Cashline and Credit Card. Combined applications must be made on the same day for the total approved loan amount to be eligible for the cashback in the respective tier.
 - (b) Application of Balance Transfer must be submitted and approved via self-apply online application platform. Applications via other channels (i.e Telesales or Branch sales staff etc.) will not be considered.
 - (c) Have entered “**DBSDF**” in the promo code field during the online application.
 - (d) Applicants will only be entitled to a one-time Cashback throughout the entire Promotion Period regardless of the number of approved applications
3. If there are more than one loan approved, the loan with the earliest approved date will be considered.
4. Cashback will be credited back to customers’ DBS Credit Cards or Cashline account within 90 days from the approval date.
5. DBS reserves the right to debit from the applicants’ DBS Cashline or Credit Card account for the value of the Cashback should there be duplicate redemptions.
6. The value of Cashback is non-transferable, non-assignable and not exchangeable for cash or in kind.
7. DBS reserves the right to replace the Cashback with any item of similar value without notice.
8. Successful Applicants will also receive the \$100 Dairy Farm Voucher in the form of two \$50 Dairy Farm e-Vouchers sent to their registered mobile number via two separate SMS (One \$50 e-voucher per SMS) within 90 days from the approval date.

9. The e-Voucher is valid only within Singapore (excluding airport stores) and its value is equivalent to the Singapore currency as stated. The e-Voucher is only applicable to be redeemed instore at Cold Storage, Marketplace, Jasons, Giant, 7-Eleven and Guardian. The e-Voucher is to be presented on your mobile device to the cashier at the time of redemption. No print outs or screenshots will be accepted.
10. The Voucher shall be forfeited if the Customer's Cashline account or Card account(s) or Personal Loan is/are terminated, suspended or in delinquent status at the point of issuance.
11. The expiry date of the Voucher is as per stated on the SMS and shall be deemed null and invalid if not utilised before the expiry date.
12. This Voucher is not refundable and cannot be replaced if lost, damaged or expired. This voucher is not exchangeable for cash and any unused balance will not be refunded.
13. DBS reserves the right to replace the Voucher with any item of similar value without notice.
14. DBS' decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.
15. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any notice or liability to any party. These Terms and Conditions shall be read in conjunction with the DBS Terms and Conditions Governing Account. In the event of any inconsistency, these Terms and Conditions shall prevail insofar as they apply to the Promotion.
