

## TERMS AND CONDITIONS GOVERNING DBS UTILITIES MARKETPLACE X PACIFICLIGHT ENERGY PROMOTION (“PROMOTION”)

### General Terms and Conditions

6. This Promotion is valid for the first 100 successful new sign-ups for each promo code during the promotion period, one redemption per sign up.
7. This Promotion is open to all DBS/POSB Current/Savings Account holders.
8. The Promotion comprises 2 categories:
  - a. Sign up for a 36-month PacificLight home plan and complete set-up of GIRO recurring payment on DBS Utilities Marketplace to enjoy a **one-time S\$60 (inclusive of GST) rebate** off your **third** month’s bill; or
  - b. Sign up for any 24-month PacificLight home plans and complete set-up of GIRO recurring payment on DBS Utilities Marketplace to enjoy a **one-time S\$50 (inclusive of GST) rebate** off your **third** month’s bill.
