

Terms and Conditions Governing the DBS Travel & Leisure Marketplace – 3X Value on DBS Points (“Promotion”)

Participation in the Promotion constitutes acceptance of these Terms and Conditions.

1. This Promotion is organised by DBS Bank Ltd (“**DBS**”) and is valid from 19 August 2022 till further notice (“Promotion Period”).
2. To qualify for the Promotion, customers must:
 - a) Be a Principal Cardmember of a DBS Points earning card (“**Eligible Card**”),
 - b) Have a minimum of 100 DBS Points in their card account,
 - c) Make a flight or hotel booking on DBS Travel & Leisure Marketplace where transactions are both offered and booked in SGD
3. A minimum of 100 DBS Points is required for redemption and maximum amount of DBS Points allowed per redemption is up to the booking transaction amount.
