- 1. The contact details will be used as communication on all CDP Services (e.g. PSN, SMS OTP for CDP Internet Services).
- 2. I/We have authority to make this update. I/We represent, warrant and certify that the information provided in this application (including without limitation the information relating to my tax residence status, tax identification number(s), and all supporting documentation and forms furnished in connection herewith) (collectively "Information") are true, complete and accurate. I/We understand that information captured in this form is for regulatory requirements under the Foreign Account Tax Compliance Act and Common Reporting Standard. We acknowledge that information contained in this form and information regarding the Securities Account may be provided to the Singapore tax authority and exchanged with tax authorities of another country or countries pursuant to intergovernmental, bilateral or multilateral competent tax authority agreements to exchange financial account information.
