

**Terms and Conditions Governing the DBS Altitude Visa Signature Card Overseas Spend Promotion (“Promotion”)**

1. This Promotion is valid from 1 November 2018 to 28 February 2019 (“**Promotion Period**”).
2. To qualify for the Promotion, Principal Cardmembers of DBS Altitude Visa Signature Card (“**Eligible Card**”) must:
  - a. Be successfully enrolled into the Promotion via [go.dbs.com/sg-altvform](http://go.dbs.com/sg-altvform) during the Promotion Period (“**Registered Cardmembers**”); and
  - b. Fulfill the following spend criteria within the Promotion Period to receive the corresponding bonus miles:

Qualifying Spend is defined as posted card-present transactions made overseas in foreign currencies from 1 November 2018, 0000hrs to 28 February 2019, 2359hrs (based on Singapore time) and excludes transactions made overseas in Singapore dollars, card-not-present transactions such as online transactions and mail/phone order in foreign currencies, posted recurring bill payment, posted 0% interest-free instalment plan, posted My Preferred Payment instalment plan, interest, finance charges, cash withdrawal, balance transfer, AXS payments, SAM bill payments, bill payments via internet banking and all fees charged by DBS.

Qualifying flight and hotel Spend will be based on posted local and foreign retail sales made via Expedia Website at [expedia.com.sg/dbsaltitude](http://expedia.com.sg/dbsaltitude) from 1 November 2018, 0000hrs to 28 February 2019, 2359hrs (based on Singapore time), and this is in accordance with [Terms and Conditions Governing the DBS Altitude Visa Signature and DBS Altitude American Express® Credit Card – 6 miles on Expedia Promotion](#).
6. Registration with incorrect information will result in a DBS Altitude Visa Signature Cardmember to be omitted from qualifying for the Promotion.
7. Supplementary cardmembers are not eligible to participate in the Promotion. However, supplementary card spend will be included in the calculation of Qualifying Spend.
8. Each Registered Cardmember is entitled to receive 1 Gift during the Promotion Period.
9. The Gift earned for the Qualifying Spend during the Promotion Period will be credited to your Eligible Card account within 90 days after the end of the Promotion Period.
