DBS Motor Insurance and Road Tax Instalment Payment Plan Terms and Conditions:

This instalment payment plan is for road tax and motor insurance payments for amounts from a minimum of \$500 and up to a maximum of 95% of the available credit limit on your DBS Credit Card account ("Card Account") at the time of your application. Your application is subject to your Card Account being in good standing as determined by us at our sole discretion and our decision is final. Should the amount you requested for exceed 95% of the available credit limit on your Card Account at the time of your application, your application will be declined. Applications that are incomplete or with incorrect information given will be rejected. The available overall credit limit of your Card Account will be provisionally reduced by a blocking out of the approved amount and will be progressively restored by the amount of each instalment payment received by us. An administrative charge of \$150 will be levied if there is an early repayment or if your Card Account is cancelled. In the latter event, this instalment payment plan will be accelerated and the balance becomes payable immediately in accordance with the DBS Card Agreement. Please allow 5 to 7 working days for application processing. In addition to these terms and conditions, you will continue to be bound by the terms and conditions governing DBS Card Agreement apply.
