

Terms and Conditions Governing the Online IT Fair 2016 Spend & Get Promotion

The Promotion

- 1. The Online IT Fair 2016 Spend & Get ("Promotion") is organized by DBS Bank Ltd ("DBS")
- 2. Promotion is valid from 8 to 14 September 2016 ("Qualifying Period").

Participation in the Promotion constitutes acceptance of these Terms and Conditions.

<u>Eligibility</u>

- 3. To qualify for the Promotion, customers must be a DBS/POSB principle Credit or Debit Card cardmember ("Cardmember") whose Card account(s) are valid and in good standing with DBS.
- 4. To qualify for the Promotion, the Cardmember must:
 - a) Charge a minimum of S\$250 on online transactions for electronics ("Qualifying Spend") to one DBS/POSB Credit or Debit Card ("Card") during the Qualifying Period
 - b) Be the first 1,500 Cardmembers to successfully register their participation during the Online IT Fair
- 5. DBS shall not be responsible for any failure or delay in posting of sales transactions which may result in a Cardmember being omitted from the Promotion.

Participation in the Promotion

Step 4:	Key in their Full Name, NRIC/Passport Number, 15/16 digit Card number (which was used for your purchases) and amount spent in the registration form. Registration must be completed by 14 Sep 2016.				
Step 5:	Select an icon to find out the prize awarded				
Step 6:	Follow the instructions on the e-coupon to get the prize. The prize e-coupon will be saved under "My Coupons" in the app.	or	Follow the instructions shown to get the prize. Take a screenshot if you would like to keep a record of the prize.		

- 7. Cardmembers must register by 14 September 2016 at 2359 hours.
- 8. Each Card can only be registered once. In the event that multiple registrations with the same Card Number are recorded, the first registration will be taken as final.



- 9. Each Card is entitled to one chance to participate in the game. If there are multiple plays detected, the first prize won will be taken as final.
- 10. Cardmembers must ensure that their particulars registered are true, complete and accurate in all respects, and that the Bank may rely on the information of this registration to contact them for purpose of this Promotion.

- The cash credit will be credited into the mobile wallet card account by 30 November 2016.
- The mobile wallet cash credit is not valid for DBS American Express Cards.
- The cash credit cannot be converted into cash advance. In the event of a card closure, balance credit will be forfeited.
- Any fraudulent claims will be referred to the police.

- 15. Installment Payment Plan ("**IPP**") transactions will qualify based on the full retail value of the IPP on the receipt.
- 16. Any refunds made on transactions that form the Qualifying Spend will result in a charge of the full retail value of the Prize to the Cardmember without prior notice.
- 17. For non-Singapore dollar Qualifying Spend charged to a Card, the transaction amount posted in the Cardholder's registered card account (which is inclusive of the exchange rate conversion and commission, if any) will be considered as the amount of the Qualifying Spend for the purpose of the minimum spend criteria for the Online Travel Fair Promotion.

<u>General</u>

- 18. DBS will have the final decision on all matters regarding the Promotion.
- 19. DBS may change these terms or suspend/terminate the Promotion without giving notice.
- 20. Notwithstanding anything herein, DBS has the absolute discretion to determine the eligibility of any person to participate in the Promotion.

If DBS subsequently determines that a person is in fact not eligible to receive the Prize or to participate in the Promotion, for any reason whatsoever, DBS may at its discretion charge the full retail value of the Prize to the Cardmember without prior notice. Each participant of the Promotion authorizes and consents to DBS charging the full retail value of the Prize to any of his/her/their DBS/POSB Credit & Debit Card account(s).
