

DBS Takashimaya Credit Cards – Up to S\$100 Takashimaya Shopping Vouchers (“Promotion”)

Terms and Conditions

1. This Promotion is valid from 23 April to 31 July 2018. (“**Promotion Period**”).
2. To qualify for the Promotion, customers (“**Eligible Cardmembers**”) must:
 - i. not hold any existing DBS Takashimaya Card; and
 - ii. not have cancelled any DBS Takashimaya Cards within the last 12 months; and
 - iii. apply online without sales assistance for a DBS Takashimaya Cards (“**Card**”) and Card must be approved during the Promotion Period; and
 - iv. fulfill the following spend criteria to receive the corresponding sign-up gift (“**Gift**”):

Spend a minimum of S\$500 outside of Takashimaya Department Store per month for <u>2 consecutive months</u> from card approval date (“ Qualifying Spend ”)	S\$100 Takashimaya Shopping Vouchers	S\$30 Takashimaya Shopping Vouchers

3. Qualifying spend refers to retail transactions charged to Card Account outside of Takashimaya Department Store and posted into the Card Account at the point of computation, but excludes interest, finance charges, cash withdrawal, balance transfer , smart cash, AXS payments, SAM online bill payments, bill payments via internet banking and all fees charged by DBS. Supplementary Cardmember accounts are not eligible to participate in the Promotion. However, supplementary card spend can be included in the calculation of Qualifying Spend under the Principal Cardmember account.
4. Each Qualified Cardmember is limited to 1 Gift during the Promotion Period. The Gift is strictly non-redeemable for cash, non-transferable, non-assignable, non-exchangeable and non-replaceable. Gift will be mailed to Qualified Cardmember’s mailing address based on the bank’s record within 60days after the Promotion Period.
5. DBS reserves the right to substitute or replace the Gift with another gift of similar value without giving any prior notice or liability to any party.

6. DBS' decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.
7. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any notice or liability to any party.
