DBS QR Gift TapLah! Bonus Round 2021

Terms & Conditions





1. The Contest

- 1.1. The Qualifying Period refers to the period between 16 January 2021 to 26 February 2021 (“**Qualifying Period**”).
- 1.2. The TapLah! Game Bonus Round is hosted under the QR Gift dashboard in PayLah! (“**Game**”) and is valid from 12:00AM to 11:57PM on 6 March 2021 (“**Game Period**”).

2. Eligibility

- 2.1. In these Terms and Conditions, “**DBS PayLah!**” refers to a mobile service offered by DBS that may be used by a user of the mobile service (individually a “**User**” and collectively, “**Users**”) to transfer funds via the DBS PayLah! application for mobile devices that can be downloaded by Users from the Apple App Store and Google Play Store (“**Application**”).
- 2.2. The Contest is open to eligible users (individually an “**Eligible User**” and collectively, “**Eligible Users**”) who:
 - a) have successfully downloaded the Application before or during the Contest Period;
 - b) have successfully registered for a wallet account in the Application (“**Wallet Account**”) before or during the Contest Period; and
 - c) have not closed their Wallet Account during the Contest Period;
- 2.3 To participate in the Contest, Eligible Users must have successfully completed qualifying transactions (“**Qualifying Transactions**”) during the Qualifying Period to be awarded 1 chance to participate in the TapLah! Game Bonus Round that is hosted under the QR Gift dashboard in PayLah! (“**Game**”).

Qualifying Transactions:

- a) Eligible User loaded and/or gave a QR Gift/ eGift to a unique Eligible User who redeemed/received it during Qualifying Period via PayLah! or PayNow
- b) Eligible User redeemed/ received a QR Gift/ eGift from a unique Eligible User during Qualifying Period via PayLah!



3. The Game (TapLah!)

3.1 The top 10 Eligible Users with the highest scores at the end of the day during the Game Period will win a daily prize of S\$138 (“**Bonus Prize**”) each. Should there be an identical score, the user who has attained the score first would rank higher, based on the timestamp as captured in DBS’ system.

3.2 Each Eligible User can only win one Bonus Prize.

3.3 The rank and eligibility of any prizes stated on the leader board is indicative and not final. DBS may, at any time at its sole discretion and without prior notice, disqualify a particular User (whether be it an Eligible User or otherwise) upon evaluation post-campaign. The next ranked eligible winner will then receive the award.

3.4 The level of difficulty of the Game for all Eligible Users is the same. This is to ensure fairness for all Eligible Users. The Game interface and sequence are standardised..

4. Conduct of the Contest

4.1 During the Contest Period, 10 top Eligible Users will win S\$138 each.

4.2 Prizes will be credited to either the winner’s Wallet Account or bank account which is linked to their Wallet Account (“**Bank Account**”) by 31 March 2021, or any other date which DBS may at its sole discretion determined, provided that the Wallet Account is not closed or blocked when the cash is being credited.

4.3 Results will be announced and published on go.dbs.com/sg-qrgift on 31 March 2021. The Winners’ Wallet Account nickname (which may be partially masked) and/or last 4 digits of their phone number will be published. Thereafter, Winners will also be notified by PayLah! Push Notification after the prize has been successfully credited to their Wallet Account or Bank account.

5. General

5.1 Participation in the Contest constitutes acceptance of these terms and conditions.

5.2 Participants consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of the participants’ personal data by/to the organizers, promoters or conductors of the Contest and such other third party for the purpose of



administering the Contest and the participants confirm that they have read and agree to be bound by the terms of the DBS Privacy Policy, as may be amended, supplemented and/or substituted by DBS from time to time, a copy of which can be found on www.dbs.com/privacy.

5.3 The decision of DBS on all matters relating to or in connection with the Contest shall be final and binding on the participants. No correspondence or claims will be entertained.

5.4 DBS shall not be liable in any way to any participant or any other person for any injury, loss, damage or expense arising out of or in connection with the Contest and the Prizes.
