

**DBS/POSB Visa/MasterCard Debit/Credit Cards and Samsung Pay
S\$10 Cashback Promotion (“Promotion”)****Terms and Conditions**

1. This Promotion is valid between 21 November and 31 December 2016 (“**Promotion Period**”).
2. To qualify for the Promotion, customers (“**Eligible Cardmembers**”) must:
 - 2.1 be an existing DBS/POSB Visa/MasterCard Debit/Credit Card (“**DBS/POSB Card**”) cardmember; and
 - 2.2 be amongst the first 5,000 DBS/POSB cardmembers to add their DBS/POSB Card to Samsung Pay for the first time during the Promotion Period; and
 - 2.3 to make valid retail transaction(s) on their DBS/POSB Card(s) via Samsung Pay during the Promotion Period.
3. The Promotion allows an Eligible Cardmember to earn a S\$10 Cashback for retail transactions on their DBS/POSB Card made via Samsung Pay on a reader/terminal that accepts Visa payWave, MasterCard PayPass or Magnetic Secure Transmission transactions in Singapore.
4. A retail transaction (both principal and supplementary cards) is determined based on posted local retail contactless sales, but excludes 0% interest-free instalment plan, recurring bill payment interest, bill payment, finance charges, cash withdrawals, balance transfer, smart cash and all fees charged by DBS Bank Ltd (“**DBS**”).
5. S\$10 Cashback (“**Gift**”) is given only if an Eligible Cardmember spends a minimum of three (3) retail transactions with an accumulated minimum spend of S\$40 during the Promotion Period. Regardless of the number of DBS/POSB Cards and/or eligible Samsung mobile devices enrolled on Samsung Pay, each Eligible DBS/POSB Customer is limited to one (1) Gift. Gift will be credited to the principal cardmember’s Card account within 60 days following the end of the Promotion Period.
6. DBS shall not be responsible for any failure of delay in posting of sales transactions which may result in an Eligible Cardmember being omitted from enjoying the Promotion.
7. DBS’ decision on all matters relating to the Promotion shall be final. No correspondence or claims will be entertained.
8. DBS may vary these Terms and Conditions or suspend or terminate the Promotion without any notice or liability to any party.
9. Eligible Cardmembers consent under the Personal Data Protection Act (Cap 26 of 2012) to the collection, use and disclosure of their personal data by/to DBS and such other third party as DBS may reasonably consider necessary for the purpose of the Promotion, and confirm that they agree to be bound by the terms of the DBS Privacy Policy, a copy of which can be found on www.dbs.com/privacy.
