

Terms and Conditions Governing DBS Remit 2017 Flight Tickets Lucky Draw (“Lucky Draw”)

Participation in the Lucky Draw constitutes acceptance of these Terms and Conditions.

1. The Lucky Draw is valid from 1st Dec 2017 to 28th Feb 2018, both dates inclusive (“**Lucky Draw Period**”).

6. Notifications with information on how to redeem the prizes will be sent to the winners within 20 working days of the Draw Date by the channels deemed suitable by DBS.
7. The following persons are not entitled to participate in the Lucky Draw:
 - (a) estates of deceased customers;
 - (b) DBS and POSB staff who worked on the lucky draw; and
 - (a) agencies and vendors who worked on the lucky draw.
8. Winners will be picked at random by DBS Bank (by manual or computerized means as DBS Bank may determine) in the presence of its’ auditors or a public witness.
