

**6 Months ProtectFirst Plan – Complimentary (“Campaign”)
Terms and Conditions (“Campaign Terms”)**

1. This Campaign is jointly organised by DBS Bank Ltd (“**DBS**”) and Manulife (Singapore) Pte. Ltd. (“**Manulife**”) (collectively, the “**Organisers**”) to be offered exclusively to customers of DBS Vickers Securities (Singapore) Pte Ltd (“**DBS Vickers**”).

7. The Organisers are not liable for any direct and indirect losses, claims, demands, expenses and/or liabilities, whatsoever in relation to the Complimentary Coverage or arising out of this Campaign.

You consent under the Personal Data Protection Act 2012 of Singapore to the collection, use, disclosure of your personal data by/to the Organisers, DBS Vickers and such other third party as the Organisers may reasonably consider necessary for the purpose of this Campaign. or correspondences will be entertained. In the event of any inconsistency between these Campaign Terms and any brochure, marketing or promotional material relating to the Product or Complimentary Coverage listed in the table above, these Campaign Terms will prevail.
