

Terms & Conditions of TravellerShield Plus Insurance Policy Promotion ("TSP Insurance Policy Promotion")

- 1. The TSP Insurance Promotion is jointly organised by DBS Bank Ltd ("**DBS**") and Chubb Insurance Singapore Limited ("**Chubb**") (collectively, the "**Organisers**"). TravellerShield Plus policy is underwritten by Chubb and distributed by DBS.
