

Bol² – Terms & Conditions

Terms & Conditions for Bol²

1. EVENT:

- a. Sqkii Pte Ltd (“Sqkii”) and DBS Bank Ltd (“DBS”) are collaborating to offer an online gaming event related to cashless payments and financial literacy branded as ‘Bol²’ (“Bol²” or “the Event”). Bol² commences on 1 June 2022, 1000 hours and ends on 30 June 2022, 2359 hours.
- b. There is no participation fee for joining Bol². The Participant(s) (“Participant”) agrees that any costs incurred while participating in Bol² is solely to be borne by the Participant.
- c. By participating in Bol², the Participant agrees and confirms:
 - i. that he/she is over the age of 18 years or, if under the age of 18 years, has the participant’s parent or legal guardian’s consent to participate in Bol²;
 - ii. to conduct himself/herself in an appropriate manner (as determined by Sqkii and DBS) throughout the event and agrees not to obstruct, or otherwise harass fellow Participants;
 - iii. to grant Sqkii and DBS all rights set out in these terms and conditions, including Clause 7 on data collection, usage and disclosure.

2. ELIGIBILITY:

- a. Staff employed by Sqkii and their immediate family members are not eligible to participate in Bol².
- b. DBS staff employed on a permanent, contract, and/or internship basis, at any point during the event period are not eligible to participate.
- c. The immediate family members of the employees of DBS, who have been directly involved in the conceptualisation, development, and execution of Bol², are also not eligible to participate in Bol².

3. LICENCE:



- a. Each Participant agrees to grant Sqkii and DBS the nonexclusive and royalty free transferable licence to publish, promote, copy, reproduce, transmit, display, edit, adapt, modify, create derivative works of and/or otherwise distribute the Participant works for the promotion and publicity of Sqkii and DBS events; in any manner, format, or media known or later devised, in perpetuity, including and without limitation to online platforms such as Facebook, Twitter, Instagram, Telegram.
- b. Each Participant also agrees to grant Sqkii and DBS the right to sublicense the rights licensed above.
- c. For the avoidance of doubt, Sqkii and DBS expressly reserve the right to adapt, edit, or modify the above-mentioned works for any promotional or marketing purposes for Sqkii and DBS.

4. BLOCKS, WEEKLY LEADERBOARD, AND PRIZES:

- a. A Participant may build items in a building session known as blocks (“Blocks”).
- b. A Participant can send his/her Blocks to the non-player character known as “Mayor Pyramid” to participate in the weekly leaderboard, where a Participant’s position on the weekly leaderboard will be determined based on the amount of Blocks he/she has sent and the time of sending.
- c. Each Participant will have to verify their DBS PayLah! account with Bol² before he/she can send any Blocks.
- d. Participants who are at specific positions on the weekly leaderboard at the end of that week will be eligible to receive cash prize(s) (collectively, “Prize(s)”). There will be four (4) weekly leaderboards throughout the Event, where the duration of each leaderboard will be specified in the game user interface at the weekly leaderboard page.
- e. There will be eight (8) Prizes to be awarded to the eight (8) Participants at the winning positions of each weekly leaderboard (collectively, “Winner(s)”), where the Prizes are denominated in Singapore Dollars (SGD):

- f. The winning positions and corresponding prize of each week will be specified in the game user interface at the weekly leaderboard page, and may not necessarily be the eight (8) highest positions.
- g. Each Participant is entitled to a maximum of one (1) Prize throughout the Event. Participants who have qualified for a Prize in a weekly leaderboard will not be eligible to send Blocks for any subsequent weekly leaderboard(s).
- h. Sqkii and DBS reserve the right to modify and/or terminate the Prizes at any time at their sole discretion without any prior notice to the Participants.
- i. Prizes will be credited by 5 August 2022 to each Winner's respective DBS bank account linked to his/her DBS PayLah! wallet, where the wallet is successfully opened no later than 30 June 2022, 2359 hours.
- j. Each Winner is responsible for ensuring that the mobile number submitted for Bol² registration is the same mobile number registered in his/her own DBS PayLah!. Sqkii and DBS accept no responsibility for any inability or failure to award the Prize(s) to a Winner(s) from inaccurate or incomplete account information.
- k. If a Winner submits his/her mobile number inaccurately as part of Bol² registration, or does not have DBS PayLah! as of 30 June 2022, 2359 hours, or is found to have closed his/her DBS PayLah! before Prizes are credited, the Winner is deemed to have forfeited his/her Prize.



- l. If Sqkii discovers that a Winner has, among other things, not conducted him or herself in an appropriate manner in the course of playing the game, or in a manner that is clearly prejudicial to the spirit of the game, the Winner will not be entitled to the Prize(s). Should the aforesaid breach be discovered after the collection of the Prize(s), such Prize(s) shall be forfeited and be returned to Sqkii on demand.
- m. Each Winner agrees to have his or her name published on Sqkii's and/or DBS's event website, and on the Sqkii's and/or DBS's Facebook, Twitter, Instagram, Telegram and any other social media accounts.
- n. The decisions made by Sqkii and DBS regarding facts connected with Bol², including the results of who are the Winners, are final. No appeals by the Participants shall be entertained.
- o. Participants must be responsible for providing complete and accurate contact information to Sqkii. Sqkii and DBS accept no responsibility for any inability or failure to contact the Participant arising from inaccurate or incomplete contact information.

5. HOURGLASSES AND CASHLESS TRANSACTIONS

- a. A Participant may obtain an in-game power-up known as an Hourglass (collectively, "Hourglasses") in Bol² by making eligible cashless transaction(s).
 - i. Each eligible cashless transaction entitles the Participant to one (1) Hourglass.
 - ii. Each Hourglass will allow the Participant to bypass the waiting time of 240 minutes for one (1) building session.
- b. An Eligible Cashless Transaction is defined as any of the following payments, which is also at least S\$1.00 in value and which has been successfully completed anytime between the time that the Participant successfully verifies his/her DBS PayLah! account with Bol² until the end of the Event:
 - i. **Transaction made with DBS PayLah! Application via any of the following:**
 - Payments to merchants through DBS PayLah! in-app checkout, merchant in-app checkout, web checkout, express checkout



- Scan & Pay transactions to pay merchants using DBS PayLah! by scanning the NETS, SG, PayNow and/or FavePay QR codes

6. DAILY MISSIONS, REFERRAL BONUS MISSIONS, AND DAILY REWARDS

- a. A Participant may receive additional rewards by completing tasks in Bol² (“Daily Mission(s)”) during the Event.
 - i. A Participant must complete the tasks as described in the Daily Mission to be eligible for the accompanying reward.
 - ii. Each Daily Mission will be valid between 0000 hours and 2359 hours, save for the Daily Mission published on the first day of the Event, which shall be valid from 1000 hours to 2359 hours on the same day.
 - iii. The accompanying rewards may change from time to time and the list of these accompanying rewards will be published in Bol² on the Daily Missions page.
- b. A Participant may receive additional rewards by completing bonus tasks in Bol² (“Bonus Mission(s)”) during the Event.
 - i. Bonus Missions are made available to a Participant each time he/she successfully refers a new Participant (“Referred Player”) to Bol².
 - ii. The Referred Player must complete the tasks as described in the Bonus Mission for the Referred Player and the Participant to be eligible for the accompanying reward.
 - iii. The accompanying rewards may change from time to time and the list of these accompanying rewards will be published in Bol² on the Referral Bonus page.
- c. Subject to DBS’s verification, Participants who are members of The Burrow by DBS on Facebook during the duration of this Event are entitled to a one-time reward of in-game items, which will be published in Bol² on the Daily Rewards page.
 - i. To join The Burrow by DBS on Facebook, a Participant must join the Facebook group at this link: <https://www.facebook.com/groups/1647933625302704> , and fill up the verification form found in the group. Then, the Participant must tap on the “I’ve Joined The Community” button in the Daily Rewards page in Bol².



- ii. Upon verification, for each subsequent day that said Participant visits the Daily Rewards page in Bol² and taps on the “Claim Today’s Reward” button, he/she will also be entitled to one (1) additional in-game item (“Daily Reward”) as specified in the game.
- iii. The accompanying rewards may change from time to time and the list of these accompanying rewards will be published in Bol² on the Daily Rewards page.

7. DATA COLLECTION, USAGE AND DISCLOSURE:

- a. By participating in Bol², the Participant expressly agrees to Sqkii's and DBS's collection, usage and disclosure of his or her Specific Participant Information for purposes such as, but not limited to, participant identification, data analysis, diagnostic testing, fraud prevention measures, and participant recognition and eligibility. Specific Participant Information includes, but is not limited to, the Participant's name, photo portrait, age, gender, email address, phone number, or any other personal information that the Participant provides to Sqkii and/or DBS. The Participant agrees to the terms of the DBS Privacy Policy, a copy of which can be found at www.dbs.com/privacy.
- b. Collection, usage and disclosure of Participant's information under Section 7 will be reasonably used and done in accordance with the laws governing the Republic of Singapore.

8. LIABILITIES:

- a. All Participant in Bol² agree that neither Sqkii, DBS nor their affiliates, employees, directors, officers, agents and/or assignees shall be liable in any way for, and shall be indemnified, released, discharged and held harmless, fully and effectively, by each Participant against and from any and all claims by any Participant or third party for:
- b. Slander, libel, defamation, violation of rights of privacy, publicity, and/or civil rights, depiction in a false light, intentional or negligent, infliction of emotional distress, copyright infringement, and/or any other tort and damages arising from or in any other way related to their participation in Bol².



- c. All injuries, losses or damages to property or person of any kind, including death, claims, actions, proceedings and other liability arising out of or caused in whole or in part, directly or indirectly, by the acceptance, possession, use or misuse of the Prize(s) or participation in Bol².
- d. Any loss, late, mechanically duplicated, illegible, incomplete, mutilated, tampered, damaged, corrupted or misdirected entries; and
- e. Any losses, costs, expenses, fees or damages incurred by the Participant arising out of or in connection with Bol² or any activity related thereto, including without limitation, any breakdown or malfunction of any computer system or equipment.

9. WARRANTIES, SEVERABILITY AND THIRD PARTY RIGHTS:

- a. Sqkii and DBS make no warranty, whether expressly or impliedly, that Bol² will be error-free and/or uninterrupted, and/or that the content or any functions associated with Bol²'s website will be uninterrupted or error-free or that Bol²'s website is free of any viruses and/or other harmful elements.
- b. Sqkii and DBS make no warranty, whether expressly or impliedly, as to any harm arising from accessing any information or material through Sqkii's websites or social media platforms, including and without limitation to harm caused by viruses or similar contamination or destructive features, whether or not known.
- c. If any term or provision of the T&Cs is held to be illegal or unenforceable, such term or provision shall be deemed to be deleted from the T&Cs and the validity or enforceability of the remainder of the T&Cs shall remain in full force and effect. Sqkii's and DBS's failure to enforce at any time the provisions of the T&Cs or any rights in respect thereto shall in no way be considered to be a waiver of such provisions, rights, or elections or in any way affect the validity of the T&Cs.
- d. The T&Cs are not intended to confer rights on any third parties, whether pursuant to the Contracts (Rights of Third Parties) Act (Cap. 53B) or otherwise, and no third party shall have any right to enforce any provision of the T&Cs.



10. GENERAL PROVISIONS:

- a. Sqkii and DBS reserve the rights to amend the Terms & Conditions without prior notice. The revised terms and conditions shall apply to Bol² from the date of publication of the revised terms and conditions on Sqkii's event website, and the Participant hereby waives any right that the Participant may otherwise have to be notified of, or to consent to, revisions of these terms and conditions.
- b. Sqkii and DBS reserve the right at its sole discretion, to suspend, postpone or terminate Bol² or shorten or extend the duration of Bol² and/or amend, modify, delete, supplement, replace or revise the Terms & Conditions, without any liability or prior notification to any person, including but not limited to any Participant.
- c. Sqkii and DBS shall not be liable to any party whatsoever for any delay in complying or failure to comply with the Terms & Conditions due to the occurrence of any event or circumstance beyond its control, including without any limitation to, acts of God, natural disasters or catastrophes, riots or wars (whether declared or not), terrorist activities, epidemics, health threats, quarantine requirements, change or issuance of new applicable laws.
- d. In all circumstances, Sqkii's and DBS's decisions shall be final, binding and conclusive on all matters relating to Bol², and no further correspondence shall be entertained. The Participant agrees and undertakes to be bound by the aforesaid decisions.
- e. The Terms & Conditions shall constitute the entire understanding and agreement between Sqkii and DBS on one hand, and the Participants on the other.
- f. In the event of any inconsistency between the Terms & Conditions and any brochure, marketing or promotional material relating to Bol², this Terms & Conditions shall prevail.

11. GOVERNING LAW:



- a. These terms and conditions shall be governed by and construed in accordance with the laws governing the Republic of Singapore.
- b. Any disputes relating to these terms and conditions shall be subject to the exclusive jurisdiction of the courts of the Republic of Singapore.
