


One-stop trade information management system which connects businesses, community systems and platforms, and government systems




Document hub for digitisation at source that enables the reuse of data - cutting costs and streamlining processes



Next-generation open platform that offers a wide range of value-added trade-related services






Manage documents and data in a digital repository

Traditional













Traditional trade processes involve resource and cost intensive archival and storage of paper documents.

Documents / data are digitised via API into reusable form and stored securely on NTP. You can also upload information into NTP manually.

Examples of document types supported on NTP:


Purchase Order, Sales Order, Commercial Invoice, Packing List, Delivery Order, Shipment Detail Specs, Schedule of Credit, Schedule of Invoice



Share and Use

Share documents/data digitally and facilitate transactions

Document sharing with multiple parties is largely manual and inefficient (through emails, courier etc).

Repeated data entry is made across multiple systems at different transaction points, leading to higher risk of input error.





Allows all trade parties to manage trade documents and trade financing needs all within the same secure NTP environment.


For Importers:
